The May 21, 2023 meeting of the BHC Parent Association will be an opportunity to have a conversation with Department of Mental Health officials about habilitation center homes of our family members.

**Federal Surveyors for Title XIX Medicaid funding** will be conducting the annual on-site survey sometime in the next several weeks. This comprehensive survey is not announced ahead time. The campus review is one aspect of oversight for quality care so that residents live in safe, healthy, supportive homes.

Plans for road repair are moving slowly.

**There continues to be a strong, persistent effort** to close all congregate care facilities like habilitation centers and to close sheltered workshops, especially by national organizations and federal government agencies. These efforts continue despite the Supreme Court 1999 Olmstead decision, interpreting the Americans with Disabilities Act of 1990 which states:

"Nothing in the ADA or its implementing regulations condones termination of institutional settings for persons unable to handle or benefit from community settings...Nor is there any federal requirement that community-based treatment be imposed on patients who do not desire it." Olmstead, at 601 – 602

"It would be unreasonable, it would be a tragic event, then, were the American with Disabilities Act of 1990 (ADA) to be interpreted so that States had some incentive, for fear of litigation, to drive those in need of medical care and treatment out of appropriate care and into settings with too little assistance and supervision." *Olmstead,* at 610.

#### **BHC ANNUAL FEDERAL SURVEY – OVERSIGHT FOR BHC RESIDENTS**

When Federal surveyors for Title 19 of the federal Medicaid law conduct an annual review of the BHC campus there are 8 Conditions of Participation from the Centers for Medicare and Medicaid that are mandated. These annual federal surveys of habilitation centers must meet these 8 Conditions of Participation:

- 1. Management
- 2. Client Protections
- 3. Facility Staffing
- 4. Active Treatment
- 5. Client Behavior and Facility Practices
- 6. Health Care Services
- 7. Physical Environment
- 8. Dietetic Services



The 8 Conditions of Participation comprise close to 500 specific standards.

In practical terms, a few areas that surveyors assess are: engagement with the residents, privacy being respected, proper food textures, clean environments, good hygiene, appropriate clothing, and active treatment requirements.

Serious deficiencies must be corrected within 90 days; other deficiencies must be corrected within a year.

Failure to correct deficiencies results in loss of certification and loss of Medicaid funding.

#### PAY RAISES FOR STATE WORKERS

Jefferson City — Today, Governor Mike Parson signed House Bill Advantage Also referred to as the Fiscal Year 2023 Early Supplemental Bill, HB 14 secures an 8.7 percent cost-of-living pay increase for all state team members and a \$2 per hour shift differential for state congregate care staff.

In January, Governor Parson called on the General Assembly to pass HB 14, which includes muchneeded pay increases for state team members. Seeing a turnover rate of nearly 30 percent and more than 7,000 positions open across state government, Governor Parson asked the General Assembly to approve the measure by March 1.

Members of the legislature recognized the unsustainable situation and heeded Governor Parson's call, giving final approval to the legislation on February 22, a full week ahead of his original deadline. State team members will see pay increases reflected in their March 31 paychecks.

#### NATIONAL SHORTAGE OF DIRECT SUPPORT PROFESSIONALS

The following information highlights some attempts to address the critical national shortage of Direct Support Professionals, who give the hands-on care for daily activities of people with disabilities.

**The Administration for Community Living** (ACL) of the federal government offers grant. <u>https://acl.gov/news-and-events/announcements/acl-launches-national-center-strengthen-direct-care-workforce</u>

"Long-standing workforce shortages have reached crisis levels during the COVID-19 pandemic; today, more than three-quarters of service providers are not accepting new clients and more than half have cut services as a result of the direct care workforce shortage. The high turnover of staff has also meant that individuals who are able to receive services often experience service disruptions and receive inconsistent care."

The ACL "has awarded a five-year grant totaling over \$6 million to establish a national center to expand and strengthen the direct care workforce across the country."

**The organization, Relias**, in partnership with the American Network of Community Options and Resources (ANCOR), recently released their 2023 DSP Survey Report. <u>https://www.relias.com/blog/direct-support-professional-dsp-survey-report</u>

Some information included in the report states "that high turnover and low retention of direct support professionals (DSPs) continues to be a top-of-mind concern for intellectual and developmental (IDD) providers. For several years now, the national turnover rate for DSPs has lingered around 50%, with some agencies having as many as one-in-eight DSP roles consistently vacant."

The report suggests some factors to consider for retention of DSPs including:

- Wages
- Appreciation, recognition, and well-being of employees
- Career advancement, training, and growth
- Respectful relationships between administration and employees

#### NATIONAL SHORTAGE OF DIRECT SUPPORT PROFESSIONALS, continued

<u>Ohio Department of Developmental Disabilities</u> is trying to build up a well- trained workforce of Direct Care Professionals as highlighted in the following article.

Ohio Department of Developmental Disabilities has innovative program for direct support professional training

Columbus-The Ohio Department of Developmental Disabilities (DODD) partnered with the Ohio Department of Education to contract with the Ohio Alliance of Direct Support Professionals (OADSP) to offer training to high school students to become Direct Support Professionals (DSPs).

"DSP-U is a unique opportunity to spark the next generation of passion for our field and support indemand jobs," said DODD Director Kim Hauck. "Partnerships like this are what will help us take our recruitment efforts to the next level."

OADSP offers the DSP-U program to high school and career/vocational schools and through partnerships with local county boards of developmental disabilities. The program provides opportunities for currently enrolled high school students interested in working with people with developmental disabilities to be better prepared for a career in the field. Students participating in the DSP-U program can earn professional credentials while receiving credit toward high school graduation requirements.

"OADSP is thrilled with this investment in future up-and-coming Direct Support Professionals. This funding provides an unprecedented opportunity to expand DSP-U across Ohio," Bethany Toledo, OADSP Executive Director, added.

The latest program launched in February at Liberty High School in Montgomery County. Students will be earning credits toward high school graduation while working toward the Certificate of Initial Proficiency credential.

DSP-U offers two types of credentials. The Basic Certificate requires the completion of 10 courses for a total of 30 hours and the Certificate of Initial Proficiency (CIP) requires the completion of 20 courses for a total of 60 classroom hours, in addition to a minimum of 100 internship hours. The CIP program is paired with enrollment in the National Alliance of Direct Support Professionals (NADSP) E-Badge academy. Students in this program earn dual Ohio and national credentials.

Missouri Department of Mental Health has an apprenticeship program for Direct Support Professionals.



In April of 2022, Governor Mike Parson announced that in response to the continuing challenges of accessing an available and skilled workforce, the Department of Mental Health (DMH), Division of Developmental Disabilities (DD), has developed *Missouri Talent Pathways*, an initiative to recruit and retain a highly skilled and dedicated workforce.

The first of its kind in the nation, *Missouri Talent Pathways* was recently approved by the U.S. Department of Labor's Office of Apprenticeship. *Missouri Talent Pathways* is now a registered apprenticeship program which blends on-the-job mentoring with technical instruction and culminates in participants receiving a certificate as a Certified Direct Support Professional. As a registered apprenticeship intermediary, the Division and its community partners will have access to an expanded applicant pool, traditional workforce development programs, and a career ladder framework for direct support professionals.

The apprenticeship is one way to help stabilize the Direct Support Professional workforce by offering a clear career path.

# The Centers for Disease Control and Prevention (CDC) released two new reports on autism <u>https://www.cdc.gov/mmwr/volumes/72/ss/ss7202a1.htm?s\_cid=ss7202a1\_w</u> <u>https://www.cdc.gov/mmwr/volumes/72/ss/ss7201a1.htm?s\_cid=ss7201a1\_w</u>

The Centers for Disease Control and Prevention (CDC) released two new reports from the Autism and Developmental Disabilities Monitoring (ADDM) Network on March 24. The reports, <u>Prevalence</u> <u>and Characteristics of Autism Spectrum Disorder Among Children Aged 8 Years</u> and <u>Early</u> <u>Identification of Autism Spectrum Disorder Among Children Aged 4 Years</u>, focus on identifying trends in the demographic makeup of children with autism and how many children with autism are being identified early. Early identification is one of the most important tools to make a difference in the lives of autistic children, leading to better outcomes, and empowering autistic children to access the services and supports that can help them thrive in the community.

Key findings from the reports include:

- The prevalence estimate of autism spectrum disorder has increased since the last report, published in December of 2021. It has increased from 1 in 44 8-year-old children to 1 in 36.
- For the first time, the percentage of 8-year-old Black (2.9%), Hispanic (3.2%) and Asian or Pacific Islander (3.3%) children identified with autism was higher than the percentage of 8year-old white children identified with autism (2.4%). The report speculates that these shifts may reflect improved screening, awareness, and access to services among historically underserved groups.
- While there have been improvements in early autism identification over time, the COVID-19
  pandemic has disrupted progress. These disruptions in the timely evaluation of children and
  delays in connecting children to the services and support they need could have long-lasting
  effects.

<u>Missouri has an Office of Autism</u> to help families find appropriate services for persons diagnosed with some level of autism.
